- LARCC has appointed the General Manager / CEO to be responsible for compliance with the Guidelines for Charitable Organisations on Fundraising from the Public.
- LARCC ensures that fundraising staff are provided with information and training on the Guidelines for Charitable Organisations on Fundraising from the Public and its implementation.
- LARCC has a feedback and complaints procedure consistent with the Guidelines for Charitable Organisations on Fundraising from the Public. Feedback is recorded for review by relevant staff including the Manager / CEO and Board. Feedback is responded to promptly and appropriately.
- LARCC prepares financial reports consistent with the requirements of the Charities Act 2009 and the Charities Regulator which include a statement concerning the extent to which control of the organisation is independent of its funding sources.
- LARCC ensures that all donations are tracked and recorded and complies with data protection requirements.
- LARCC is accessible to the public through a number of readily available contact options.
